Unique initiatives

We are particularly proud of them, so we want to tell you more.



The nationwide monitoring of the information content of the courts of appeal of Ukraine with materials that promote the openness of justice and facilitate interaction with the media and the community.

The monitoring campaign took place between January and June. The Human Rights Vector team formed a group of monitors from all over Ukraine. All of them – people from all walks of life – were trained, and they monitored free of charge the courts of appeal. A total of 31 courts were monitored. During the whole period, 37 monitoring visits were made and 32 court buildings were visited.

The conclusions of the monitoring campaign and the recommendations made are available in a separate publication report. It is important that many recommendations have already been taken into account by the courts. Some courts, including those that did not participate in the survey, used the positive experience of their colleagues.

The All-Ukrainian Marathon of Teaching and Methodological Developments of Law Teaching "Trial Broadcasting: Theory through Practice"

The marathon was held from April to May in cooperation with the Ministry of Education and Science of Ukraine and the National Academy of Law Sciences of Ukraine. The marathon was aimed at broadening the experience of using interactive methods of law teaching. We suggested to the teachers to use online trial broadcasts available on the Judiciary of Ukraine website (court.gov.ua/affairs/online) as a real visualization of the court hearings.

Following the results of the Marathon, the manual "Teaching through Practice: Experience of Using Trial Broadcasts in Law Teaching" was presented, which included 22 described classes in different legal disciplines. These classes are not only described in detail but also tested by the leading Ukrainian higher education institutions that are preparing a new generation of lawyers.

The Journalism Contest "Trial in Simple Words"

The Contest was aimed at raising public awareness of the organization of the judicial system, implementation of judicial reform, specific court cases, increase of interest and public confidence in the judiciary. The acceptance of works lasted from August to October (inclusive). A total of 93 works were submitted – not only by journalists, but also bloggers.

48 participants represented most of the territory of Ukraine, namely 17 oblasts.

On November 21st, on the Dignity and Freedom Day and at the same time on the International Television Day, we awarded the authors of the best works. The Contest was won by 5 journalists: Viktoriia Matola (1st place), Yevheniia Virlych (2nd place), Olha Koval (3rd place) and Tatiana Bezruk (category "Best material on the Maidan-related cases"), Serhii Andrushko (category "The material using commentary from the court communication team").
